CONSENT ORDER

WHEREAS Stephen J. Edwards, Regional Appraisal Coordinator of the Ministry of Forests issued the nineteen Stumpage Advisory Notices setting out stumpage rate determinations under s. 105 of the *Forest Act* for certain cutting authorities held by Teal Cedar Products Ltd. as identified in Appendix 1 to this Order (collectively, the "Determinations");

AND WHEREAS the Appellant Teal Cedar Products Ltd. has appealed each of the Determinations under the Appeal Nos. identified in Appendix 1;

AND WHEREAS the Appellant and the Respondent agree to conclude these appeals by way of a consent order of the Forest Appeals Commission;

NOW THEREFORE the Forest Appeals Commission orders, by consent and pursuant to its powers under section 149 of the Forest Act that:

- 1. Each of the determinations be rescinded and remitted to the Regional Appraisal Coordinator for re-determination;
- 2. The Regional Appraisal Coordinator determine the stumpage rate using Shoal Island as the appraisal log dump for the purposes of calculating
 - (a) the Estimated Winning Bid under Chapter 4; and
 - (b) the applicable Tenure Obligation Adjustments under Chapter 5 of the Coast Appraisal Manual;

3. The Regional Appraisal Coordinator issue new stumpage advisory notices for each of the cutting authorities identified in Appendix 1 based on the determination referenced in paragraph 2 of this Order.
